ORDER

The Administrative Sanction was accorded for an estimate amounting to Rs.244 Crore for the construction of 220/110kV SCADA enabled Gas Insulated Switchgear Substations at Pathanamthitta and Kakkad and its associated lines under Sabari Lines and Substation package as part of TransGrid 2.0, Phase 1 project as per B.O. read as 1st above.

The Chief Engineer, TransGrid has reported as per note read as 2nd above that, sufficient suitable land for the proposed GIS Substation Kakkad is available with the Dam Safety Division, Seethathode. The Chief Engineer, TransGrid has further reported that the transfer of the said land is very urgent, as the construction of the associated Transmission lines to the proposed substation has already been awarded and is scheduled for completion by January 2022. So the Substation work is to be taken up urgently.

As the site development works are time consuming, the Chief Engineer, TransGrid has requested sanction to transfer the above land (approx. 1.5 acres) now in possession with the Dam Safety wing, to the Executive Engineer, TransGrid, Kottayam.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in its meeting held on 15.05.2020,

Resolved to accord sanction to transfer sufficient land (approx.1.5 acres) under the custody of Dam Safety Division, Seethathode to the Executive Engineer, TransGrid, Kottayam for the construction of 220/110kV GIS Substation at Kakkad.
