### ORDER

M/s. Kaveri Pet & Polyforms Pvt. Ltd. (HTB.13/3799) is a non-live HT consumer of Electrical Section, Kolenchery under Electrical Circle, Ernakulam. The consumer has an outstanding arrear amounting to ₹ 69,44,553/- as on 31.10.2019 (including interest) towards current charges from the consumption month of 03/2011 to 06/2012. Due to the default in payment of current charge, the service connection was disconnected on 14.11.2011 and subsequently dismantled on 25.09.2012 as per rule.

The Revenue Recovery action was initiated against the consumer for realizing the arrear amount through the District Collector, Ernakulam. The Revenue Recovery action is still pending in the Ernakulam Collectorate.

The consumer as per letter read as 2<sup>nd</sup> above has requested for One Time Settlement scheme sanctioned as per order read as 1<sup>st</sup> above. Accordingly, as per Board Order read as (3) above sanction was accorded to the consumer to clear the arrears under OTS Scheme 2019-20. The total arrear amount including interest under

OTS Scheme sanctioned to the consumer was ₹ 40,53,300/- as on 31.10.2019. The consumer has also submitted an application before the Vydyuthi Adalath held on 25.01.2020 at Ernakulam District and it was decided in the Adalath to extend the benefit of OTS Scheme to the consumer.

Thereafter, the consumer has submitted a representation read as (4) claiming mistakes in the calculation of fixed charges after disconnection and also regarding the refund of Security Deposit and its interest for the year 2011-12. After rectifying the anomalies the OTS amount is arrived as ₹ 34,46,409/- instead of ₹ 40,53,300/-.

Accordingly, the matter was placed before the Full Time Directors as per note read as (5) above. The Full Time Directors in its meeting held on 15.05.2020 resolved to accord sanction to modify the B.O. (FTD) No.169/2020 (SOR/AMU 5/HTB 13/3799/OTS/2019-20) dated 07.03.2020, sanctioning OTS Scheme to the consumer Kaveri Pet & Polyforms Pvt. Ltd., Kolenchery (HTB 13/3799).

Orders are issued accordingly.
