## **ORDER**

The Mankulam Hydro Electric Project (40 MW) in Idukki District, a priority project of the KSEBL is in the land acquisition stage. The total land required for the implementation of the project is 80.013Ha, which include 11.913 Ha. forest land, 15.16 Ha. Government land (river bed) and 52.94 Ha private land. About 86% of the land required has already been procured by KSEBL based on the Government Order read as 1<sup>st</sup> above. The balance non patta land to be procured for the project is only 5.83 Ha (river puramboke and land under intension notification).

The District Level Purchase Committee (DLPC) entrusted for land acquisition in its meetings held on 20.06.2018 and 24.10.2018 finalised the land value including land under intention notification and river puramboke, but decided that the payment for land under intention notification and river puramboke shall be effected subject to Government decision only. KSEBL sought sanction from Government for effecting payment for this as per the rate approved by the DLPC. As per G.O read as 3<sup>rd</sup> above, the Government has accorded sanction to KSEBL for effecting payment for the land under intention notification & river puramboke as per the rate approved by the DLPC.

KSEBL as per B.O read as 2<sup>nd</sup> above had decided that the payment of Rs.3,17,73,745/towards taking over of 2.85Ha land under intention notification and Rs.1,64,35,485/-towards taking over of 1.27Ha river puramboke for Mankulam HEP shall be effected after getting concurrence /sanction from the Government. This payment can now be effected by KSEBL by adopting the G.O(MS) No.3/2020/PD dtd 19.05.2020.

The proposal was placed before the Full Time Directors as per note read as 4<sup>th</sup> paper above. Having considered the matter in detail,the Full Time Directors in its meeting held on, 22.05.2020,resolved to adopt the G.O(MS) No.3/2020/PD dtd 19.05.2020 for effecting payment for the land under intention notification & river puramboke at the rate approved by DLPC for Mankulam HEP.

The Chief Engineer(Civil- Investigation & Construction Central) shall take further necessary action in this regard.

Orders are issued accordingly.
