ORDER

KSEB Ltd as per B.O read as 1st above has accorded sanction among others to direct all the custodians of Forest land leased out to KSEBL to get the entire extent of forest land under their jurisdiction surveyed and demarcated on ground and that the demarcation of forest land shall be carried out by erecting four feet high permanent cement concrete (RCC) boundary pillars duly numbered at an interval of 30 meters.

The Chief Engineer(Civil- I& CC) as per note read as 2nd above reported that now the Deputy Chief Engineer, Generation Circle, Moozhiyar has reported that erection of four feet high permanent cement concrete (RCC) boundary pillars would be uprooted/destroyed by wild animals. Hence it has been suggested that demarcation of forest land shall be carried out by erecting survey stones of two feet length by partial modification of the Board Order read as 1st above.

The Chief Engineer(Civil- I& CC) recommend to accord sanction for undertaking demarcation of forest land leased out for Sabarigiri Hydro Electric Project by erecting survey stones of two feet length by partial modification of the Board Order BO(FTD) No: 55/2019(DGC/AEEV/Forest/2014) dated 22.01.2019 to that extent .

The matter was placed before the Full Time Directors in the meeting held on 22/5/2020 as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors Resolved to accord sanction for undertaking demarcation of forest land leased out for Sabarigiri Hydro Electric Project by erecting two feet high permanent Reinforced Cement Concrete (RCC) boundary pillars duly numbered at an interval of 30 meters and to modify the B.O(FTD) No: 55/2019(DGC/AEEV/Forest/2014) dated 22.01.2019 to the above extent.

The B.O(FTD) No: 55/2019(DGC/AEEV/Forest/2014) dated 22.01.2019 stands modified to the above extent.


