Execution of Transgrid 2.0 project - Formation of additional TC Division at Kottarakkara - Sanctioned - Orders issued.

ORDER

The execution of various works included in the TransGrid 2.0 project is progressing fast. All the works in Phase I of the project have been awarded and are under different stages of execution. The total estimated cost for the awarded works amounts to Rs. 2712 Crore. Also, many schemes in Phase-II have already been tendered. The DPR for the rest of the works are under approval/preparation stages.

The Transgrid team entrusted with the execution of works estimated to cost more than Rs. 5000 Crore is operating with very minimum staff. There are only two TC Divisions each under the Deputy Chief Engineer, Transgrid South and North at present. They are head quartered at Kozhikode, Shornur, Ernakulam and Kottayam.

Of the above, the Transgrid TC Division, Kottayam alone is assigned with as many as 11 major schemes including the construction of two 400kV Substations and six 220kV Substations along with associated 400/220/110kV transmission lines. The Chief Engineer, Transgrid as per note read '1' above has pointed out that as more works enter in to execution stage, it will be practically impossible for a division to execute such a huge quantum of works spread across five districts. In this regard, it is proposed to strengthen the Transgrid team under Deputy Chief Engineer, Transgrid (South) with additional offices for carrying out the activities under Transgrid 2.0 project in Thiruvananthapuram, Kollam and Pathanamthitta Districts.

Considering the quantum of works currently assigned to Transgrid TC Division, Kottayam and also in view of the request of the Chief Engineer, Transgrid the Director (Transmission, System Operation & Safety) as per note read '3'above proposed to form one Transgrid TC Division head quartered at Kottarakkara and one Subdivision at Sasthamkotta under the new Division. It is proposed to form the new offices by suitable deployment of posts with the staff pattern given in Table 'A' below.

As regard to the posts to be deployed, the Director (T, SO & S) suggested that out of the five teams posted for shift duty at LD station, Kalamassery, one team (leave reserve) comprising one Executive Engineer (Ele.), one Assistant Executive Engineer (Ele.) and one Assistant Engineer (Ele.) can be deployed to the new offices under Transgrid.

The balance requirement of one Assistant Engineer (Ele.) can be deployed from BDPP. As per B.O read '2' above, sanction has been accorded to suitably deploy all the places from BDPP except that required for station maintenance. It is further proposed to deploy one post of Assistant Executive Engineer (Civil) in consultation with Director Generation (Civil) and the post of Sub Engineer (Ele.) from TC Division, Punalur.

As such, the timely completion of the project is very essential. The importance of the project is evident from the fact that the Chief Minister himself is monitoring the progress of its execution.

The matter was placed before the Full Time Directors for decision. The FTD meeting held on 22.5.2020 discussed the proposal in detail and

Resolved to accord sanction to form one Transgrid TC Division and one Transgrid

TC Subdivision under Deputy Chief Engineer, Transgrid (South) and head quartered at Kottarakkara and Sasthamkotta respectively through deployment, with the staff pattern shown in Table 'A'.

Further resolved to accord sanction for accommodating the new offices in Vydyuthi Bhavanam, Kottarakkara till alternate arrangements are made.

Orders are issued accordingly.
