## **ABSTRACT**

North Malabar Lines Package under TransGrid 2.0— Construction of 220/110 kV MCMV line from Thalassery to Kunnamangalam —Administrative Sanction accorded -Orders issued.

#### **ORDER**

The Chief Engineer (TransGrid) submitted a Detailed Project Report with the estimate for an amount of Rs 232.97 crores (Rupees Two hundred and thirty two crores and Ninety Seven lakhs only) for the North Malabar Lines Package which involves the construction of 220/110 kV MCMV line from Thalassery to Kakkayam (NMLP-Project-A) & 220/110 kV MCMV line from Kakkayam to Kunnamangalam (NMLP-Project-B) under TransGrid 2.0.

### The proposal includes:

- A) Construction of 58 km of 220kV MCMV transmission line from Powerloom metta in Kannur district to Kakkayam in Kozhikode district through the existing Right of Way (ROW) of 66kV OHL and 110kV double circuit OHL for an amount of Rs 158.22 crore
- B) Construction of 30 km of 220kV MCMV transmission line from Kakkayam to Kunnamangalam in Kozhikode district through the existing Right of Way (ROW) of 110kV double circuit OHL for an amount of Rs 74.75 crore

This project envisages the construction of 220/110kV MCMV transmission line with 22m reduced RoW to avoid additional land requirement, public protests and compensation issues. Special towers KL series KLA, KLB, KLC, KLD and GL series towers GLA,GLB,GLC,GLD are proposed for the purpose of 220/110 kV line in reduced RoW and its selection will be based on tower footing space availability at each location. Twin Panther conductor is proposed for 220 kV side and single Panther conductor for the 110 kV side. The project completion period will be 24 months for Project A and 18 months for Project B.

The project is included in the TransGrid Project-Phase II and is to be funded from KIIFB. The Load flow study conducted is confirming the benefits and technical feasibility. The peak load system loss

is seen to be reduced by 16.6MW which corresponds to an average annual energy savings of about  $80.42 \, MU$ . The IRR value calculated is  $9.52 \, \%$ .

The DPR committee held on 24.04.2020 approved the proposal and decided to place the matter before the FTD for approval. Sanction had been accorded as per order read as 1<sup>st</sup> above for the Phase -II works of the TransGrid 2.0 package amounting to Rs.2172 Cr. The Board has also authorized the Full Time Directors to accord Administrative Sanction for the estimate for individual works in Phase -II.

The Director (T, SO&S), as per note read as 2<sup>nd</sup> above elaborated on the technical and financial viability and necessity of the project and placed the proposal before the Full Time Directors.

Having considered the matter in detail, the Full Time Directors in the meeting held on 22.05.2020, Resolved to accord Administrative sanction for the following.

- Construction of 58 km of 220kV MCMV transmission line from Thalassery in Kannur district
  to Kakkayam in Kozhikode district through the existing Right of Way (RoW) of 66kV OHL and
  110kV Double circuit OHL as part of TransGrid 2.0 project at an estimated cost of Rs 158.22
  crore
- Construction of 30 km of 220kV MCMV transmission line from Kakkayam to Kunnamangalam in Kozhikode district through the existing Right of Way (RoW) of 110kV double circuit OHL ,as part of TransGrid 2.0 project at an estimated cost of Rs 74.75 crore

Further resolved to accord sanction to submit the DPR of North Malabar Lines package(Phase-II) to KIIFB for securing funding as part of TransGrid 2.0 project.

Orders are issued accordingly.
