ORDER

KSEB Ltd decided as per Board Order read 2 above to constitute a Project Management Team for Soura Project in the Northern Region consisting of the following officials.

- (i) Executive Engineer – 1 No.
- (ii) Assistant Executive Engineer – 1 No
- (iii) Assistant Engineer – 1 No

It was also decided to deploy the post of Executive Engineer, RM Division, Moolamattom to Soura North, Kozhikkode. Also the Chief Engineer (HRM) was directed to identify one place of Assistant Executive Engineer and Assistant Engineer by way of re-deployment. However shifting the post of Executive Engineer, RM Division, Moolamattom has not been effected.

As per B O read 3 above, it is decided to deploy the post of the Executive Engineer (Ele)- 1 No, Assistant Executive Engineer(Ele)- 2 Nos and Assistant Engineer (Ele)- 1 No. from BDPP to suitable places during the General Transfer, 2020.

The matter regarding modification of the B O read as 2 above deploying the post of Executive Engineer , BDPP to Soura Project (North) and also shifting places of Assistant Executive Engineer - 1 No and Assistant Engineer - 1 No from BDPP to Soura Project (North) was placed before the Full Time Directors as per the note read as 4 above.

Having considered the matter in detail, the Full Time Directors meeting held on 30.05.2020,

- (i) Resolved to accord sanction to modify the B O dated 13.2.2020 deploying the post of Executive Engineer RM Division, Moolamattom to Soura Project (North), Kozhikode to the extent that the post of Executive Engineer, BDPP, Ernakulam is deployed to Soura Project (North), Kozhikode.
- (ii) Further resolved to accord sanction to shift one post of Assistant Executive Engineer and one post of Assistant Engineer at BDPP to Soura Project (North).
