Enhancing km limit of hired vehicle (lorry) attached to the Electrical Sub Division, Chalakkudy under Electrical Circle, Irinjalakuda – Sanctioned – Orders issued

ORDER

The Chief Engineer (Distribution Central), Ernakulam as per letter read as 2nd above has reported that the Deputy Chief Engineer, Electrical Circle, Irinjalakuda had requested sanction for enhancing the monthly km limit of the hired vehicle (lorry) attached to the Electrical Sub Division, Chalakkudy from the existing 1,500 km to 1,800 km. It is also reported that the vehicle is used for transporting materials under Electrical Sub Divisions of Chalakkudy and Koratty, the biggest Sub Divisions under Electrical Division, Chalakkudy. The jurisdiction of Electrical Sub Division, Chalakkudy is spread upto Malakkappara, Tamil Nadu border, which is 80 km away.

In the above circumstances, the Chief Engineer (Distribution Central), Ernakulam has requested sanction for enhancing the monthly ceiling of the hired vehicle (lorry) attached to the Electrical Sub Division, Chalakkudy from 1,500 km to 1,800 km.

The matter was placed before the Full Time Directors as per note read as 3d above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 30/05/2020, resolved to accord sanction to enhance the monthly km limit of the hired vehicle (lorry) attached to the Electrical Sub Division, Chalakkudy under Electrical Circle, Irinjalakuda to 1,800 km from the existing 1,500 km, subject to the condition that no further excess will be sanctioned in future.

Orders are issued accordingly.
