ORDER

KSEBL as per order read as 1st above has accorded sanction to award the work of "Design as per site conditions, erection, testing & commissioning of Grid Tied Ground Mounted Solar PV Power plant at Brahmapuram (4 MW), Kanjikode (3MW) and Agali(1MW) with an installed capacity of 8MWp, including operation & maintenance of the plant for the first 5 years from the date of handing over " to M/s Inkel Ltd. Accordingly the Letter of Award was issued on 23.11.2019 and the agreement executed on 20.01.2020.

Also KSEBL as per order read as 2nd above has accorded sanction to deploy the post of Executive Engineer (Elec.) BDPP and to retain one Asst. Engineer (Ele.), one Sub Engineer(C) and two electricity workers at BDPP and also to direct Chief Engineer (REES) to avail the service of the retained staff for carrying out the allied works of Solar plant as per requirement.

The Chief Engineer (REES) as per note read as 3rd above has reported that the Executive Engineer, BDPP (Generation) was the Engineer in Charge for the implementation of the proposed SPV plant at Brahmapuram and the Executive Engineer Transmission Division, Palakkad was the Engineer in charge for the SPV plants at Agali and Kanjikode. It is further reported that the site clearance work at Brahmapuram is in the preliminary stage and frequent follow up action with Social Forestry Department is essential for obtaining necessary sanction for tree cutting works etc. and the service of an officer not below the rank of Executive Engineer is required for this and also for the execution of the work. Hence the Chief Engineer (REES) has requested to appoint the Executive Engineer, Transmission Division, Brahmapuram as the Engineer in Charge for the implementation of 4MWp SPV plant at Brahmapuram.

Having considered the matter in detail, the Full Time Directors meeting held on 18.06.2020 resolved to accord sanction to appoint the Executive Engineer, Transmission Division Brahmapuram as the Engineer in Charge for the implementation of 4MWp SPV plant at Brahmapuram.

Orders are issued accordingly.
