## **ORDER**

The Executive Engineer (Project Manager, Special Task force, Thiruvalla) was entrusted with the liasoning and co coordinating the construction activities of the Pugalur - Thrissur HVDC project, a mega project being executed by the Power Grid Corporation of India Ltd. The project, when completed will enhance the import capability of the State by another 2000MW.

The Chief General Manager, PGCIL as per letter read as 2<sup>nd</sup> above addressed to the Secretary, Power Department, Government of Kerala has appreciated the good support from KSEBL task force headed by Sri George Mathew in resolving the RoW issues with regard to the recently completed Edamon – Kochi Corridor as well as the ongoing HVDC project . Since Mr. George Mathew , Executive Engineer has retired from service on superannuation w.e.f 31.05.2020, M/s PGCIL also expressed their desire to have the continued support of the same team till the completion of the HVDC project. It is further communicated that they are making all efforts to complete the tower foundations before the onset of monsoon so as to complete the entire project at the earliest.

In this regard, the Secretary , Power Department , Government of Kerala as per letter read  $1^{st}$  above has informed that Sri. George Mathew is willing to continue with the present works in order to complete the task already assigned to him.

As per letter read 1<sup>st</sup> above, the Secretary(Power), Government of Kerala has intimated that PGCIL has accepted the payment of the establishment cost of Rs. 75000/- per month from 01.06.2020 for a period of six months in this regard.

The matter was placed before the Full Time Directors as per note read as 5<sup>th</sup> above .

Having considered the above, the Full Time Directors in the meeting held on 18.06.2020,

Resolved to accord sanction to intimate PGCIL regarding the establishment cost (Rs.75000x6) of Sri. George Mathew, former head of Special Task Force of KSEBL for 400kV Edamon- Kochi Line and 320kV Pugalur- Thrissur HVDC line as per the letter no. PWR-C2/43/2020/POWER / 14.05.2020 from Secretary(Power), Government of Kerala by the existing ARU (Transmission Division, Pathanamthitta).

Further resolved to accord sanction to provide the existing vehicle and CUG for the use of Project Manager , Special Task Force .
