## ORDER

State Public Health and Clinical Laboratory, Thiruvananthapuram (LCN 24/7295) is an HT live Government consumer under Electrical Circle, Thiruvananthapuram (Urban). The consumer has an outstanding arrear amounting to ₹ 32,90,683/- pertaining to the period 07/2016 to 10/2019. The consumer was intimated of OTS Scheme 2019 on 09.01.2020, as per which the arrear amount at reduced rate of interest is ₹ 31,57,310/- (Rupees Thirty One Lakh Fifty Seven Thousand Three Hundred and Ten only).

In the Vydyuthi Adalath held at Thiruvananthapuram on 19.02.2020 the consumer as per the application read  $2^{nd}$  above, has requested to sanction OTS for remitting the arrear amount of ₹ 31,57,310/- in four bi-monthly instalments exempting the interest component.

The Vydyuthi Adalath decided to allow OTS with six instalments and to give time upto April 2020 for payment of the 1<sup>st</sup> instalment since the consumer is a Government Institution.

The matter was placed before the Full Time Directors as per note read as 4<sup>th</sup> above.

Having examined the matter, the Full Time Directors in the meeting held on 18.06.2020 resolved (Agenda Item 29/6/20) to accord sanction to permit the consumer, State Public Health and Clinical Laboratory, Thiruvananthapuram (LCN 24/7295) to clear the arrears under OTS Scheme 2019. Further resolved to grant time for payment of 1<sup>st</sup> instalment within 30 days.
