ORDER

The Consultancy Wing, KSEBL has been entrusted with 10 Major Hospital Projects funded by KIIFB as on date, with a cumulative project outlay of around Rs.800 Crores. Out of the above, work has been awarded for 3 Projects namely, Mattannur, Kottarakkara & Karunagappally and the financial evaluation is in its last stage for the project at Kundara for which work will be awarded shortly .

Posting of employees to the Consultancy Wing has been made strictly as per adaptability to the new tasks & nature of work, from the already sanctioned staff strength based on requirement. Hence even though there is a sanctioned strength of 15 Nos. of Consultancy Assistant (Sub Engineers-Civil) in the Consultancy Wing, currently Consultancy Wing is having a working strength of 6 Nos. of Sub Engineers (Civil) only. So at present, Consultancy Wing is yet to appoint 9 Nos. of Sub Engineers (Civil).

1. Posting of Sub-Engineers (Civil) for the Speciality Hospital project Site at Mattannur:

It has been decided in the 7th Meeting of the Empowered Committee on Consultancy held on 03.03.2020 , to recommend the postings of the following 3 Nos. Sub Engineers (Civil) at the Speciality Hospital project Site at Mattannur, for which the preliminary works have already been started :

2. Posting of Sub-Engineers (Civil) to the Project Execution Team for Kollam Region :

The Site Supervision of Hospital projects in Kollam District, namely Taluk Hospital-Kottarakkara, Karunagappally & Kundara, actually require a set of three Sub-Engineers (Civil) each. However, considering the proximity of the projects with one another and the fact that full-fledged work may take longer to actualize, 6 Sub-Engineers may be posted to the Project Execution Team for Kollam Region which can cater to the other Hospital projects in the pipe line also, viz. District & Victoria Hospitals at Kollam.

It has been decided in the 9th Meeting of the Empowered Committee on Consultancy

held on 19.05.2020 to recommend the postings of the following 6 Nos. Sub Engineers (Civil) to the Project Execution Team for Kollam Region as below:
