ORDER

As per letter read above, it is informed that the State Data Centre-II located at Technopark, Thiruvananthapuram is facing acute shortage of data storage space for running software Applications. Hence Kerala State IT Mission has requested to allocate 100TB of SAN storage space from KSEB Data Centre on temporary basis for a period of 6 months.

The Chief Engineer (IT, CR & CAPs) in the Note read as 2nd above has reported that as part of implementation of various IT projects under IPDS, KSEB has recently procured two nos. of SAN Storage system with 500TB capacity, one each at Data Centre and DR Centre. Steps are being taken to migrate the core business Applications like LT billing, SCM etc. which are running in the old HP SAN Unit to the newly procured SAN System. The requirement of KSITM is to provide 100TB storage space on SAN so that the Servers connected to the SDC-II network can access the storage based on permissions. M/s KSITM is planning to make use of the above storage space by linking KSEB Data Centre and SDC-II through a dedicated fibre link. As per Note (2) above, sanction was also requested to allocate 100TB of SAN storage space from KSEB Data Centre to M/s KSITM on temporary basis for 6months for hosting the software Applications at SDC-II, subject to the following conditions:

- 1. KSITM shall ensure advanced cyber security measures for preventing virus attacks and unauthorised access
- 2. In case any support is required for providing 100TB SAN Storage space to KSITM from the OEM Vendor M/s Huawei, the cost involved shall be met by KSITM
- 3. The work shall be carried out with utmost care and in case any damage happens to KSEB IT Systems at Data Centre due to KSITM, the entire cost shall be reimbursed by KSITM.

Considering the above Note, the Chairman & Managing Director, KSEBL has accorded sanction for allocation of 100TB of SAN storage space from KSEB Data Centre subject to the above conditions and directed to place the matter before FTD for ratification.

The matter was placed before the Full Time Directors as per Note read (3) above. Having considered the matter in detail, the FTD in its meeting held on 16.4.2020 resolved to ratify the decision to allocate 100TB SAN storage space from KSEB Data Centre to KSITM on temporary basis for 6 months for hosting the software Applications at SDC-II.

Orders are issued accordingly.
