ORDER

The Chief Engineer(IT, CR & CAPs) as per the note read as 4 th above, has reported that the 3 year contract period for providing SMS Gateway Services had been expired and new RFP read as 1^{st} above was invited for selecting the new service providers with an EMD of Rs 7.15 lakk as per the existing conditions and EMD was also exempted for Kerala Government Public Sector Undertakings.

M/s BSNL as per the letter read as 2^{nd} above, has requested to exempt the EMD of Rs.7,15,000/- (Rupees Seven Lakh Fifteen Thousand only) for participating in the tender read as 1^{st} above, by considering them as a Central PSU and the exemptions given by other GoK departments like Directorate of Survey and Land records and Director of Fisheries.

In view of the above the Chief Engineer (IT,CR & CAPs) has recommended, to exempt M/s BSNL from submiting the EMD, as BSNL being a Government of India Public Sector Undertaking and their long term association with KSEBL for various activities.

Having considered the matter in detail, the Full Time Directors in its meeting held on 20.04.2023 resolved to accord sanction to exempt M/s.BSNL from furnishing the Earnest money Deposit for participating in the tender/RFP invited by KSEBL as BSNL is a Govt.of India Public Sector Undertaking.
