ORDER

The Construction of 220kV Gas Insulated Substation at Thalassery and its associated 220/110kV Multi Circuit Multi Voltage line from Mundayad to Thalassery were completed under TransGrid and the substation was energised on 31.01.2023. The inauguration of the substation was conducted on 08.04.2023 by the Hon'ble Chief Minister Sri. Pinarayi Vijayan.

The Chief Engineer, TransGrid as per the note read as 2nd above submitted an estimate amounting to Rs.3,00,000/- for conducting the inaugural function. In the meeting convened on 27.03.2023 by the Swagatha Sangham under the Chairmanship of Adv.A.N Shamseer, the Hon'ble Speaker of Kerala Legislative Assembly, it was pointed out that being the Government 'second Anniversary and since the function is inaugurated by the Hon'ble CM, more than 1000 people are expected to attend the function and appropriate arrangements are to be made accordingly.

As per the existing delegation of powers, the expenditure that can be incurred for inauguration of major substations (66kV and above) is limited to Rs. 1,00,000/-. Since more audience is expected in the inaugural function of Thalassery Substation, higher amount than the approved amount for state level inaugural functions is needed so as to meet the requirements as per relevant safety protocols. The matter of allocating an additional amount of Rs. 2,00,000/- for meeting the expenses of the scheduled inaugural function is placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter, the Full Time Directors in the meeting held on 11.05.2023,

Resolved to accord sanction to the Chief Engineer, TransGrid for spending an amount limited to Rs. 3,00,000/- (Rupees Three Lakhs only) for conducting the inauguration ceremony of 220kV Gas Insulated Substation, Thalassery by the Hon'ble Chief Minister, Sri. Pinarayi Vijayan.

Further resolved to submit proposal for appropriate threshold delegation.
Orders are issued accordingly.


