### ORDER

The Chairman & Managing Director, KSEBL in the note read as 5<sup>th</sup> above has directed to put up a proposal for One Time Settlement Scheme -2023 to be submitted before the Government of Kerala and KSERC for approval. In compliance to the above, the Chief Engineer (Commercial & Tariff) as per the note read as 6<sup>th</sup> above has placed 2 schemes before the Full Time Directors for approval. Having considered the note in detail, the Full Time Directors in its meeting held on 05.05.2023;

- i) Resolved to approve the new OTS-2023 scheme in line with the regulation 136(5) of Kerala Electricity Supply Code, 2014 to be submitted before the Hon'ble Commission.
- ii) Further resolved to accord sanction to provide the reduced rate of interest in the OTS-2023 scheme immediately upto December 2023 as shown below;
  - Age of arrears above 15 years – 4%
  - Age of arrears between 5 years and 15 years -5%
  - Age of arrears above 2 years and below 5 years -6%
- iii) Further resolved to authorize the Deputy Secretary(Administration) to issue a demand draft /cheque for RS 10,000/- (Rupees Ten Thousand only) drawn in favour of Secretary, KSERC Vellayambalam, Thiruvananthapuram.
- iv) Further resolved to authorize the Chief Engineer (IT & CR) to make necessary provision in the Oruma Software for extracting the details/ report in respect of arrears settled under OTS scheme for submitting the same to the Hon'ble Commission in the prescribed formats, within the stipulated time.
- v) Further to authorize the PRO to work out a specific campaign for implementation of OTS-2023.


