### ABSTRACT

### ORDER

The Divisional Forest officer has requested for 5 cents of Forest land under lease to KSEBL at Idukki, for the proposed water storage & treatment plant and pipe line, well etc. at Veliyamattom area.The water supply scheme is proposed under **Jaljeevan Mission-Arakkulam** of Kerala Water Authority. Also requested NOC from KSEBL, for the implementation of the said project at the above location. The land area proposed at Veliyamattom includes the forest land portion (5 cents) which was leased way back from Forest Department to KSEBL for the implementation of Idukki HEP. The proposed plant is close to the filter House of KSEBL in survey No.632/94, which is used for the IHEP colony water supply at Moolamattom. As the allignment for laying the pipe lines and allied installations initially proposed by KWA has been revised due to the expected damages to the Road & drainage facilities already constructed in the locality by KSEB with the consent of Forest Department.

After conducting joint site inspection and discussions,the revised alignment sketch along with location map has been submitted by the KWA authorities and requested approval for the same. As per the new alignment, 2 Nos. of Transmission Main-200mm(8") pipe and 4 nos of Distribution pipe line -100mm(4") are passing through the said land area where roads,rubble masonry walls built by KSEBL are existing, which cannot be disturbed. It is reported that any type of leakage in the above pipe lines may cause severe damages to the above roads and walls existing in the location. In order to protect the above installations and interests of KSEBL, it is suggested to have an agreement between KSEBL and KWA ,such that any possible minor/ major damages caused to the KSEBL installations in the said area ,due to the leakage in the above pipe lines of KWA shall be rectified by rebuilding the installations by KWA at their cost.

issuing NOC for the transfer of 5 cents of land to the Forest Department /KWA, for the implementation of water storage & treatment facility at Veliyamattom area, proposed under **Jaljeevan Mission-Arakkulam** of Kerala Water Authority. Also requested to enter in to an agreement between KSEBL & KWA for recitfying the damages occurred by rebuilding of the damaged installations in that area, due to the possible leakage in the pipe lines and water storage facility by KWA.

The matter had been placed before the Full Time Directors as per the note read as 2<sup>nd</sup> above with a recommendation to hand over the land to the Forest Department concerned along with NOC, but it was deferred. After discussion in the high level meetings with KWA the matter was again placed before the Full Time Directors as per the note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors meeting held on 11.05.2023 resolved to accord sanction to issue NOC to KWA for 5 cents of forest lease land at Veliyamattom area under IHEP for taking up with Forest Department for the proposed construction of water storage and treatment plant, well etc. under **Jaljeevan Mission-Arakkulam** of Kerala Water Authority subject to the conditions

- a) That the lease charges are to be paid by KWA.
- b) KWA shall rectify and rebuild any damages caused to the KSEBL istallations in the locality by executing an agreement.

Further resolved to authorise the Chief Engineer(Generation) to issue NOC to KWA and to authorise the Deputy Chief Engineer,Generation Circle,Moolamattom to sign the above agreement on behalf of KSEBL.

Orders are issued accordingly.
