## ORDER

Sanction was accorded for the functioning of a PHC at the premises of Sholayar power Station and to provide an ambulance on contract basis at Sholayar power station premises as per the B.O. read as 1<sup>st</sup> above.

The Chief Engineer, Generation as per the letter read as 3<sup>rd</sup> above has made a comparison between providing ambulance on contract basis vis a vis procuring one ambulance .The Chief Engineer (Generation) has further forwarded an estimate amounting to Rs.22,50,000/- , for the procurement of a new Force Traveller Patient Transport Ambulance Non –AC B-type, P/S, ABS, BSVI(WB-3350) or any other similar model for Sholayar Power House.

The matter was placed before the Full Time Directors as per the note read as 4<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors meeting held on 11.05.2023

Resolved to accord sanction to an estimate amounting to Rs.22,50,000/- (Rupees Twenty Two lakh Fifty Thousand only), for the procurement of a new Force Traveller Patient Transport Ambulance Non–AC B-type,P/S,ABS, BSVI(WB-3350) through GEM portal for Sholayar Power House, instead of hiring an Ambulance with Driver

Further resolved to authorise the Chief Engineer(Generation) to do the procurement.

Further resolved to explore the possibility of getting a driver from Health Services,subject to the condition that the Ambulance shall be stationed at Sholayar.

Orders are issued accordingly.
