Formation of Transmission Construction Subdivision, Kattappana under Transmission Circle, Thodupuzha for executing Transgrid downstream works and formation of Transmission Construction Section, Kidangara under Transmission Circle, Alappuzha for executing works under Rebuild Kerala Initiative - Sanction accorded- Orders issued.

ORDER

The Chief Engineer (Transmission South), as per the letter read as 1st above requested sanction for forming a new Transmission Construction Subdivision at Kattappana under Transmission Circle, Thodupuzha for executing the Transgrid downstream works and a new Transmission Construction Section at Kidangara under Transmission Circle, Alappuzha for executing the works under Rebuild Kerala Initiative, so that the planned works could be executed in a time bound manner.

The Chief Engineer reported that most of the 66kV substations in Idukki district (Vazhathope, Kattappana, Nedumkandam, Peerumedu & Vandiperiyar) are getting upgraded to 110kV & 220kV levels in addition to the construction of new 220kV substation at Nirmala City and 110kV substation at Anakkaramedu as part of Transgrid project. Also, the 66kV radial feeders in Idukki district are getting upgraded to 110kV & 220kV level. These works include construction of Kuthunkal-Nedumkandam, Kattappana-Peerumedu lines and upgradation of Vazhathope-Nedumkandam, Nedumkandam-Kattappana and Mundakkayam-Peerumedu lines. The preliminary works of all these projects are now being handled by the respective Transmission Subdivisions.

For ease of execution and timely completion of the Transgrid downstream projects, the Chief Engineer (Transmission South) suggested forming a Transmission Construction Sub Division at Kattappana under Transmission Division, Nedumkandam by shifting and renaming the Transmission Circle Store, Ambalappuram under Transmission Circle, Kottarakkara. It is also suggested that the existing TC Section Peerumedu, TC Section Murikkassery and TC Section, GEC may be brought under the new TC Sub division.

Similarly, for the execution of works under Rebuild Kerala Initiative in a time bound manner, the Chief Engineer (Transmission South) has requested sanction for forming a new Transmission Construction Section at Kidangara under Transmission Division, Alappuzha by shifting and renaming the TC Section, Vilakkulam under Transmission Circle, Thiruvananthapuram.


