ORDER

Following the receipt of complaints and representations from various associations and individuals, demanding rate hike for contract meter readers in KSEBL, the Chairman and Managing Director as per note read as 5th bove, entrusted a committee consisting of Director (Distribution, IT and SCM), Director (Finance) and Chief Personnel officer to study the issue regarding emoluments and to put up a proposal with rationale.

The matter was examined by the Committee.

The uniform rates for meter readings fixed as per B.O. read as 1^{st} above were increased by 10% as per B.O. read as 2^{nd} above and a further hike of 10 % was given on these rates as per B.O. read as 3^{rd} above.

Considering the representations in the light of the above facts, the committee has submitted the following proposal for effecting rate hike of meter readers.

"The qualification required for Meter readers in KSEBL is ITI certification. But the meter reading work involves visiting of consumer premises, taking meter readings and uploading the readings to KSEBL billing servers. The Transportation for visiting consumer premises is arranged by meter readers themselves and hence the cost of transportation is also a deciding factor in their remuneration. The Cost of transportation is directly dependent on fuel cost.

A hike of 10% as below is proposed. (However the rate in City area is proposed to be reinstated to the original rate of Rs 5.81)".

The matter was placed before the Full Time Directors as per note read as 7th above. Having considered the matter in detail, the Full Time Directors in its meeting held on 18.05.2023,

Resolved to allow a 10% hike for the rates for preparation of estimates for engaging personnel on work contract basis for taking meter readings from the rates specified in the B.O. (FTD) No.538/2020 (D(D&IT)/D6-AE2/Revision of rates/2019-20/0001) dated 19.08.2020' in areas other than "city".

Further resolved to reinstate the rate fixed for "City" region vide B.O. (FTD) No. 427/2021 (D(D&IT)/D6-AE2/LTS-2021/2020-21/0001) dated 04.06.2021 to the original rate of Rs 5.81/- per reading.

The revised rates with effect from May 2023 are given below.
