ORDER

The Chief Engineer (Civil-Dam Safety & DRIP) reported as per the Note read as 1st above that the Naval Physical & Oceanographic laboratory (NPOL) is one of the major laboratories of the Defence Research & Development Organization (DRDO), Ministry of Defence, Govt. of India and a Memorandum of Understanding read as 3rd above has been executed between M/s. NPOL and KSEBL for establishing a 'Submersible Platform for Acoustic Characterization and Evaluation (SPACE)' facility in Idukki reservoir for testing and evaluation of sonar systems and their project is going on.

The Chief Engineer further reported that the Project Director (SPACE), NPOL has requested as per letter read as 2nd above to share the water level of ldukki reservoir for the period from December 2021 to March 2023 and for the month of December 2020 for establishing a bathymetric profile of the reservoir in the digital domain, which shall be mutually beneficial, as part of their Project.

Accordingly, the Chief Engineer (Civil-Dam Safety & DRIP) has requested to accord sanction for sharing the reservoir data with M/s. NPOL at free of cost, subject to the condition that M/s. NPOL shall share a copy of the results of the bathymetric survey conducted by them with KSEBL considering the fact that M/s. NPOL is an Organization under the Ministry of Defence, Govt. of India and the results of the bathymetric survey would be beneficial to KSEBL also.

Having considered the recommendation of the Chief Engineer (Civil - Dam Safety & DRIP), sanction is here by accorded by the Director (Generation - Civil) for sharing the reservoir
