ORDER

During the various review meetings conducted at Government level, the need for enhancement of Hydro power capacity of Kerala was discussed. Obtaining Forest clearance and public protest are the major challenging issues faced by the state in the development of hydro power. Partnering with Central Public Sector Undertakings is expected to give certain leverage, especially in obtaining Forest & Environmental Clearance. In the meetings, it was suggested to utilise the expertise of central power utilities like M/s.NHPC & M/s.THDCIL. The draft MoU for development of Hydro Projects in the state of Kerala, to be executed among Government of Kerala, M/s. THDCIL & KSEBL, was forwarded to the Government of Kerala as per the DO Letter read as 2nd above for in principle approval.

The matter was placed before the Full Time Directors as per the note read as $4^{\,\mathrm{th}}$ above for ratification.

Having considered the matter in detail, the Full Time Directors in the meeting held on 05.06.2023:

Resolved to ratify the action in having forwarded the draft MoU among Government of Kerala, KSEBL & M/s. THDCIL, Rishikesh for the development of Hydro power Projects in the state for obtaining in principle approval of the Government.

Further resolved to place the matter before the Board of Directors for approval.

The Honourable Minister, Chief Secretary and CMD, THDCIL along with officers of KSEBL and THDCIL conducted a meeting and it was instructed that KSEBL shall submit a proposal by studying JV model and its benefit or shortfall approved through Board to Government within 15 days. The Director (Generation- Electrical) in charge, Director (Generation- Civil) and Director (Finance) in charge shall take immediate follow up actions.

Orders are issued accordingly.
