ORDER

KSEBL as per B.O read as 1st above has accorded sanction to permit M/s TELK, Angamaly to use the 60MT Weigh Bridge owned by KSEBL and installed at the premises of B&S Division, Angamaly subject to the terms and conditions stipulated in the order & the validity of the same was one year from the date of the order.

Later, the permission was extended for subsequent years with the newly proposed rates and with an additional condition that service tax, if any, shall be borne by M/s.TELK. The latest extension of the weighment facility was permitted to M/s. TELK as per B.O. read 2nd above for a period of one year with effect from 05.05.2022 subject to the existing terms and conditions but at the revised rates contained therein with applicable GST.

Now the Chief Engineer (Civil - Construction) South as per letter read as 3rd above has reported that the permitted period as per B.O. dated 06.06.2022 has expired on 04.05.2023 and M/s. TELK has requested to extend this facility for two more years under the same rates, terms and conditions. The Chief Engineer has recommended to accord sanction for extending the facility permitted to M/S. TELK with the existing rates, terms and conditions as stipulated in B.O. (FTD) No. 490/2022 (DGC/AEEVI/Fab-Angly/2014) dated 06.06.2022.

The matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail the Full Time Directors in its meeting held on 05.06.2023, Resolved to accord sanction for extending the weighment facility permitted to M/s.TELK for using the 60 MT Weigh Bridge owned by KSEB Ltd., installed at the

premises of B & S Division, Angamaly for a further period of one year with effect from 05.05.2023 subject to the existing rates, terms and conditions as per B.O. (FTD) No. 490/2022 (DGC/AEEVI/Fab-Angly/2014) dated 06.06.2022 as agreed by M/s.TELK.
