ORDER

The Administrative Sanction of Rs 80,30,000/- (including GST) has been accorded by KSEBL as per the BO read as 1st above for the purchase of 2 sets of 110V, 645 Ah Plante type battery bank for Power House auxiliary DC Supply and one set of 110V, 535 Ah, Plante Type Battery Bank for the enhancement of existing 400 Ah Battery Bank at Switchyard with associate accessories and recommended tools through open tender.

In the e- tender read as 2nd above with PAC of Rs.80,30,000/- only one bidder has participated and hence the same was retendered on 05.01.2023. In the retender also, only one bidder, M/s SR Power Solutions, Solaris1D Wing, 247 Opp LT Gate No.6, Powai Saki Vihar Road Anderi E, Mumbai 400072. has participated. Being the retender, the prequalification documents of the single bidder has been provisionally admitted for evaluation. M/s SR Power Solutions is the authorized channel partner of M/s EXIDE industries limited and submitted the 'letter of authorization'. Based on the evaluation of bid documents submitted, M/s SR Power Solutions has been prequalified and accordingly the price bid has been opened on 13.04.2023. The total amount quoted by them in the price bid is Rs. 85,58,848/- (All inclusive rate), which is 6.59% above PAC of Rs.80,30,000/-.The bidder was requested to submit the rock bottom offer for the subject work and the total amount quoted for the work in rock bottom rate is Rs.85,23,448/-, which is 6.15% above PAC.

Considering the urgent requirement and in order to maintain the redundant DC

system in the power house and at the switchyard at Sabarigiri Hydro Electric Power Project and since the work has been tendered twice, the Chief Engineer (Generation) has requested orders to accord sanction for awarding the subject work of "Supply,Installation and Commissioning of 2 sets 110 V 645 Ah Plante type battery bank for Power House auxiliary DC Supply and one set 110 V 535 Ah plante Type Battery Bank for the enhancement of existing 400 Ah Battery Bank at Switchyard with associate accessories and recommended tools" to the lone qualified bidder M/s SR power Solutions, Mumbai at their rock bottom price of Rs.85,23,448.00 (all inclusive rate with taxes) at 6.15 percent above the probable amount of contract.

The matter was placed before the Full Time Directors as per the note read as 5th above.

Having considered the matter in detail the Full Time Directors in its meeting held on 05.06.2023 observed that due to present exigency after cancellation of 465MW contracts by KSERC and urgent repairs in Kakkayam loosing another 110MW arose, it is of paramount importance to ensure that all functional power houses are functioning optimally. In spite of repeated tenders, single bid is recieved.

Therefore resolved to accord sanction for awarding the subject work of "Supply,Installation and Commissioning of 2 sets 110 V 645 Ah Plante type battery bank for Power House auxiliary DC Supply and one set 110 V 535 Ah plante Type Battery Bank for the enhancement of existing 400 Ah Battery Bank at Switchyard with associatef accessories and recommended tools" to the lone qualified bidder M/s SR power Solutions, Mumbai at their rock bottom price of Rs.85,23,448.00 (all inclusive rate with taxes) at 6.15 percent above the probable amount of contract.
