ORDER

As per Purchase Plan for 2023-24 approved as per Board Orders read as 1st & 2nd above, 3 Nos., 25MVA, 110/22kV Transformers are required for Transmission Wing under Transmission Circle, Palakkad. Power Transformers with voltage ratio of 110kV/22kV are exclusively for the Substations under Transmission Circle, Palakkad. As per the Board order read as 2nd above, the total amount arrived for the procurement of 3Nos. 25MVA, 110/22kV Transformers is Rs.10,80,55,395/- (Approx.), @ Rs. 3,60,18,465/-. Updated rates as per latest Purchase Order is taken for estimate purpose.

The Director (T, SO, P, G-E & S) as per note read as 3rd above intimated that for meeting the increasing power demand in Palakkad Industrial area, proposal for constructing a new 110/22kV substation near to the existing 110/22kV substation at Kanjikode in the land under the custody of Generation wing is being finalized and construction of the same is expected to start soon. Hence, there is an additional requirement of 2Nos of 110/22kV, 25MVA Transformers and necessary steps shall be taken to purchase 5nos. of 110/22kV, 25MVA Transformers instead of 3Nos as included in the purchase plan 2023-24.

Considering the additional requirement of 2Nos 25MVA,110/22kV Transformers an additional financial commitment of Rs.7,20,36,930/- will be incurred with a total financial commitment of Rs.18,00,92,325/-(Approx.) (Rupees Eighteen Crore Ninety Two Thousand Three Hundred and Twenty Five Only).

The matter was placed before the Full Time Directors as per note read as 4th above.

Having examined the matter in detail the Full Time Directors in the meeting held on 23/06/2023 resolved to accord sanction for the procurement of 5Nos. of 110/22kV, 25MVA transformers for financial year 2023-24 with a total financial commitment of Rs.18,00,92,325/-(Approx.)(Rupees Eighteen Crore Ninety Two Thousand Three Hundred and Twenty Five Only).

Orders are issued accordingly.
