### ORDER

The Administrative and Technical sanction of Rs.13 Lakhs has been issued for the construction of Store cum office building at Poozhithode SHEP . Even after tendering the subject work with PAC of Rs.10,99,782.42/- twice, only single bidder participated. Sri.Dinu Raju, Managing Partner, Sweyer Constructions, 11/103A, Kozhikode, the sole participant in the tender was qualified in the Technical evaluation and the Quoted rate for the work is Rs.10,87,684.81/- excluding GST which is 1.10% below the PAC.This was confirmed as the rock bottom rate by the bidder, when sought, after opening the tender.The Chief Engineer (Generation) reported the rare chance of getting another bidder, even after tendering the work twice and being the construction site in very remote area.

The KSEBL has accorded sanction as per the B.O. read as 1<sup>st</sup> above, to the circle level committee constituted to accept and issue sanction for single quotation/tender received for offers to carry out the work at estimate amount/below estimate amount,after retendering for all contract works having PAC upto Rs.20 Lakhs in distribution works. It was also accorded sanction to the Chief Engineer Level Committee constituted to accept and issue sanction for single quotation/tender received for offers to carry out the works with overall tender excess of upto 5% above PAC,after retendering for all contract works having PAC upto Rs.20 lakhs in distribution works.

Considering the fact that in the delegation of powers,the acceptance of single tender is not mentioned and similar requests are submitted from Generation and Transmission wing for necessary sanction for single tender/quotation of works, it was recommended to adopt the above B.O. to the entire works in KSEBL.

The Chief Engineer(Generation) has requested sanction in accepting the single bidder in the tender for the Construction of Store cum office building amounting to Rs. 10.87.685/-

GST at Poozhithode SHEP in favor of Sri. Dinu Raju, Managing partner, Sweyer constructions, Kozhikode.

The matter was placed before the Full Time Directors as note read as 4<sup>th</sup> above.

Having considered the matter in detail the Full Time Directors in its meeting held on 05.06.2023 resolved to accept the single bid in favour of Sri. Dinu Raju, Managing partner, Sweyer constructions, Kozhikode with the quoted amount of Rs. 10,87,685/- (Rupees Ten Lakh Eighty Seven Thousand Six Hundred and Eighty Five Only) excluding GST in the tender for the Construction of Store cum office building at Poozhithode SHEP and to award the work to him.

Further resolved that the Board order B.O. (FTD) No.646/2022 (DIRDIT-AE2/2022/E-Tender/002) dated 22.07.2022 shall be made applicable to all the works at KSEBL.

Orders are issued accordingly.
