ORDER

The Chief Engineer (Transmission South) as per note read 3rd above has reported that National Highway Authority of India (NHAI) intent to acquire 0.118 Ha of land under the possession of KSEBL in the premises of 66kV Substation, Karuvatta as part of the widening of National Highway (NH 66). The land is in resurvey No.492/04, Block No.3 in Karuvatta Village, Karthikappally taluk in Alappuzha district. Also, the compound wall of length 175m and two gates of the substation are to be demolished and reconstructed in connection with the road widening. As per the proceedings read as 1st and 2nd above, the Special Deputy Collector & Competent Authority LA (NH), Alappuzha has awarded a compensation of Rs.1,86,12,940/- for the demarcated land and Rs.57,32,720/- for demolishing the compound wall, gates and old control room, which has been credited to KSEBL's account.

Since NHAI has already remitted the compensation amount, the Chief Engineer (Transmission South) requested sanction for transferring the 0.118 Ha of land to NHAI.

The matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 15.06.2023, resolved to accord sanction to hand over 0.118 Hectares of land under the possession of KSEBL at 66kV Substation, Karuvatta, in resurvey No.492/04, Block No. 3 in Karuvatta Village, Karthikappally Taluk in Alappuzha district to National Highway Authority of India for the widening of NH66, by accepting the compensation amount of Rs.1,86,12,940/- (Rupees One Crore Eighty Six Lakh Twelve Thousand Nine Hundred and Forty Only) for the

demarcated land and Rs.57,32,720/- (Rupees Fifty Seven Lakh Thirty Two Thousand Seven Hundred and Twenty Only) for demolishing the compound wall, gates and old control room of the substation, as awarded by the Competent Authority.

Orders are issued accordingly.


