### ABSTRACT

Request for changing conventional Broad Band land line connection & FTTH plans used in KSEBL offices to FTTH plan (Plan 499 100GB - CS358) - Administrative Sanction Accorded - Orders issued.

### ORDER

The Deputy Chief Engineer, System Operation Circle, Thiruvananthapuram as per note read as 1<sup>st</sup> above requested sanction to convert the conventional land line based broad band connections presently used in KSEBL offices to new FTTH connections, citing that the conventional connections are not reliable and are facing frequent connectivity and speed issues and the existing copper lines are not properly maintained by BSNL.

Further, the KFON connectivity presently given to some of the KSEBL offices are also facing connectivity issues and the KFON team has not yet set up a maintenance or connection restoration team, which cause delay in rectifying the issues. Also the roll out of KFON connection is reported to be delayed further.

Hence, the Deputy Chief Engineer, System Operation Circle, Kalamassery requested sanction to permit KSEBL offices to avail FTTH plan CS358 (Rs.499/- with 1000 GB data per month), which provides unlimited internet (50 Mbps till 100 GB, 4 Mbps beyond) and VoIP call facility to any network without changing the current telephone number, till a stabilized connection is established under KFON project. The financial commitment for the same is reported as Rs. 499 + GST per month per connection. BSNL has offered to waive the security deposit, one time charge, installation charge, modem rent etc. and also avoided advance payment for the connection charges.

The matter was placed before the Full Time Directors meeting as per note read as 2<sup>nd</sup> above. Having considered the matter in detail, the Full Time Directors in its meeting held on 15.06.2023 resolved to accord sanction for converting the existing land line based broadband connections to FTTH connection (Plan 499, 1000 GB, CS358) with a monthly rent of Rs. 499/- (+GST) per connection, till a stable connectivity is provided through KFON project.


Further resolved to disconnect all additional telephone connections after converting to FTTH
