ORDER

The Chief Engineer, Kerala Water Authority as per letter read as 1st above has informed about the proposed water pumping and storage system proposed for the drinking water supply schemes at various locations in Idukki District, under Jaljeevan mission, a joint venture of Central and State Governments. It is envisaged for providing drinking water supply to Rajakkad, Baison Valley, Rajakumari, Senapathy, Konnathadi, Udumbanchola Panchayath areas in Idukki District. Also requested for one Cent land near to Ponmudi Dam for constructing transformer control room and allied equipment along with water lines of the pumping system for taking 22MLD water from Ponmudi Dam using floating pumps.

In this regard, specific remarks were obtained as per letter read as 2nd above, from the Chief Engineer (Generation). It is reported that the land requested for the control room is in the catchment area of the Dam and on the right side of the Ponmudi-Pallicity road and around 100m from the Ponmudi Dam top to Marakkanam. As teak plantations of the Forest Department are existing in the said land area, it is suggested that permissive sanction may be given for using the one cent of land near to Ponmudi Dam for the above purpose, subject to the approval of the Forest Department. Also, reported that the proposed land area and the buildings near to the Dam had already been handed over to Hydrel Tourism Centre during 2019 from the Dam Safety wing and retarring works of the road towards the Dam has been carried out with the supervision of the Dam safety wing, during 2021.

In this regard, the Director (Generation-Civil) on behalf of Dam Safety wing, as per note read as 3rd above, has reported that they have no objection in issuing permissive sanction to KWA for the subject project.

The matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors' meeting held on 23.06.2023 resolved to accord permissive sanction to the Kerala Water Authority, for using one Cent of Forest lease land, near to Ponmudi area for constructing transformer control room and allied equipment along with water lines of the pumping system for taking 22MLD water from Ponmudi

- KWA have to obtain NOC from the Forest Department before commencement of the work
- The lease charges of the said land portion to the Forest has to be paid by KWA
- The damages, if any, caused to the KSEBL installations, road etc in the locality may be restored to its original condition by KWA, by executing an agreement.

Further resolved to authorize the Chief Engineer (Generation) to issue NOC to KWA and authorize Deputy Chief Engineer, Generation Circle, Meencut to sign the agreement on behalf of KSEBL.

Further resolved that while communicating to KWA, the decision taken in the meeting by the Hon'ble Chief Minister regarding Escrow account and dues to KSEBL shall be referred.

Orders are issued accordingly.


