ABSTRACT

Jalajeevan Mission- drinking water supply scheme - request of KWA for allotting KSEBL land at two locations in Pallivasal - Sanction accorded - Orders issued.

ORDER

The Chief Engineer (Generation) as per letter read as 2nd above has forwarded the request of KWA for transfer of land, 2 cents each Meencut KSEB Colony and Pallivasal Power House colony, for the proposed drinking water storage & supply system under Jalajeevan mission.It is informed that the Government sanction has already been obtained for the project proposed above as per G.O.(Rt) No.489/2021/WRD dated 18.09.2021. The details of land area as per the revenue records reported are as follows:

- 2 cents at Meencut colony (Pallivasal Village, Survey No.48, Block No.14)
- 2 cents at Pallivasal Power house colony (Pallivasal Village, Surevy No-263, Block No-14)

It is reported that, the above land area is under the jurisdiction of the Deputy Chief Engineer,Generation Circle, Meencut and recorded as "sarkkar" in the revenue records. As the proposed water supply system is beneficial for KSEBL staff colonies at the above localities, it is recommended that the above land areas can be handed over to KWA for the implementation of the projects subject to a condition that providing the water connections to the KSEBL colonies shall be under top priority.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors meeting held on 23.06.2023 resolved to give permissive sanction to the Kerala Water Authority, for using 2cents of land under KSEBL each at Meencut colony (Pallivasal Village, Survey No.48, Block No.14) & at Pallivasal Power house colony (Pallivasal Village, Surevy No-263, Block No-14) for the implementation of drinking water storage & supply system under Jalajeevan mission, subject to the following conditions:

- providing the water connections to the KSEBL colonies shall be under top priority.
- The damages, if any, caused to the KSEBL installations, road etc in the locality may be restored to its original condition by KWA, by executing an agreement

Further resolved to authorize the Chief Engineer (Generation) to issue NOC to KWA and to authorize the Deputy Chief Engineer, Generation circle, Meencut to execute the agreement

Further resolved that while communicating with KWA, the decision taken in the meeting conducted by the Hon'ble Chief Minister regarding back dues to KSEBL and Escrow account shall also be referred and follow up action shall be taken on the decision taken in the meeting by the Hon'ble Chief Minister.

Orders are issued accordingly.
