ORDER

KSEBL had formed a Land Management Unit (LMU) as per B.O. read as 1st above to sort out and solve all the land related issues of landed properties of KSEBL under a Chief Co-ordinator. Subsequently, Sri.Radhakrishnan C., Retired Spl.Dy. Tahsildar, KSFE (RR) was appointed on contract basis since May 2015 as per B.O. read as 2nd above for handling all matters related to landed assets of KSEBL across the State including addressing day to day issues, site visits, discussions with revenue officials etc. The service was extended several times and the period expired on 04/2023.

The Chief Co Ordinator, Land Management Unit as per the letter read as 3rd above has reported that about 100 land parcels are yet to be sourced from different Land Acquisition Offices for effecting mutation which has to be completed in a time bound manner and requested to extend the services of Sri.Radhakrishnan C., Retired Spl.Dy. Tahsildar, KSFE(RR) to assist the Land Management Unit for a further period of one year with effect from May 2023 on contract basis @ a remuneration of Rs. 35,000/- per month (Rupees Thirty-Five Thousand only) inclusive of all expenses in partial modification of the conditions of services as ordered as per the B.O. read as 2nd above to that extent and all other terms and conditions remaining the same.

The matter was placed before the Full Time Directors as per note read as 4th above. Having considered the matter in detail, the Full Time Directors in the meeting held on 23.06.2023, Resolved to extend the services of Sri. Radhakrishnan C., Retired Special Deputy Tahsildar, KSFE (RR) for a further period of one year with effect from May 2023 on contract basis @ a remuneration of Rs.35,000/- per month (Rupees Thirty Five

Thousand only) inclusive of all expenses in partial modification of the conditions of services as ordered vide B.O. (DB) No.1075/2015 (109/LMU/GEN/2014) dated 29.04.2015 and all other terms and conditions remaining the same.

Further resolved to authorize the Chief Engineer (HRM) to disburse the remuneration based on the monthly attendance statement furnished from the LMU.
