ABSTRACT

Consultancy Wing- Deployment of the post of Executive Engineer(C) to Kannur Region of Consultancy Wing- Sanctioned - Orders issued.

ORDER

Consultancy Wing is presently implementing various public projects including 10 Hospital projects funded by KIIFB, with a total outlay of Rs.871 Crores. These include two major Hospital Projects in Kannur region viz, the ongoing Speciality Hospital, Mattannur with an outlay of Rs.99,91,07,816/- & Taluk Hospital, Iritty with an outlay of Rs. 64,01,61,757/-which is about to commence.

The Head - Consultancy Wing, vide Note read as 2nd above has reported that, inorder to effectively co-ordinate and give timely decisions for the efficient implementation of these projects, an Executive Engineer level officer is essential in the Kannur region exclusively for these projects. The Contractor has also taken up the issue of lack of decision making at site in the review meeting held by the Director (Generation - Civil) recently.

It is also reported that the post of Executive Engineer (Civil) in IT Wing has been shifted to Consultancy Wing, vide BO read as 1st above, thereby making the posts of Executive Engineer (Civil) in Consultancy Wing to 3 nos.

The Head - Consultancy Wing has suggested that considering the urgency involved, one post of of Executive Engineer (Civil) out of the existing three posts be shifted to Kannur Region urgently, exclusively to attend to the two Hospital Projects viz, Speciality Hospital, Mattannur & Taluk Hospital, Iritty and a suitable Engineer be posted immediately in the imminent promotion order to the cadre of Executive Engineer (Civil) and the Director (Generation - Civil) has recommended the same.

Having considered the above, sanction is hereby accorded to shift one post of Executive Engineer (Civil) out of the three posts available in Consultancy Wing to Kannur Region of Consultancy Wing urgently and to post a suitable Engineer immediately in the imminent

promotion order to the cadre of Executive Engineer (Civil), considering the exigency involved.

Orders are issued accordingly.
