As per the revised Purchase Plans for Transmission Wing for the financial years 2022-23 & 2023-24 sanctioned as per B.Os read as 3<sup>rd</sup> & 4<sup>th</sup> respectively, following Control Cables are required:

It was decided to tender the items included in Purchase Plan 2022-23 along with the requirement of Purchase Plan 2023-24 since enough stock was available at that time. Since a sudden decrease in stock has been noticed, Additional PO No.. SCM.93/2022-23/8143 dated 17.02.2023 was issued to M/s. Rajasthan Cables & Conductors Pvt Ltd. for the following quantities as per the proceedings of Purchase Sub Committee dated 17.02.2023:

As per Cl-9 of the Purchase Order read as 1<sup>st</sup> above, Purchase Order for an additional quantity up to 25% over and above the original ordered or tendered quantity will be placed if the supplier is willing to supply the additional quantity at the same rates, terms and conditions of the original Order and also accepts KSEBL's price re-fixation clause.

Control Cables of various sizes are included in the bid for Vendor Registration- Phase II (RFVR-II) dtd 12.10.2022 and technical evaluation of 11 bidders is under progress. Since the procurement of materials through RFVR-II will be time consuming and stock of the items are diminishing quickly, the previous suppliers, M/s. Rajasthan Cables & Conductors Pvt Ltd and M/s. Dynamic Cables Ltd were requested to inform their willingness to supply additional quantity of Control Cables as per Purchase Order conditions as below:

M/s. Rajasthan Cables & Conductors Pvt Ltd intimated their willingness as per letter No. RCC/2023-24/186 dated 30.05.2023 to supply the following items as additional quantity against Clause-9 of the Purchase Order read as 1<sup>st</sup> above. M/s. Dynamic Cables Ltd intimated their **unwillingness** to supply the above items. The additional quantity proposed for purchase comes to 50% of the quantity purchased against previous tender.

The Chief Engineer (SCM) as per note read as 5<sup>th</sup> above has recommended to place Additional Purchase Order for 13 km of 2 x 2.5 sq.mm Control Cable, 10 km of 4 x 2.5 sq.mm Control Cable, 4.5 km of 2 x 4 sq.mm Control Cable and 23 km of 4 x 4 sq.mm Control Cable with M/s. Rajasthan Cables & Conductors Pvt Ltd, Jaipur as additional quantity for meeting the immediate requirement as per Purchase Plans 2022-23 & 2023-24 for Transmission Wing with a total financial commitment of Rs.76,02,327/- at the same rates, terms and conditions of the original Order as per KSEBL's price refixation clause as specified in the Original Purchase Order. Also intimated that tender for the balance quantity is proposed to be floated soon.

Rajasthan Cables & Conductors Pvt Ltd, Jaipur at the same rates, terms and conditions of the original Purchase Order and also applying KSEBL's price refixation clause as specified in the Original Purchase Order for the Additional Order also. The total financial commitment due to the above purchase will be Rs.76,02,327/- (Rupees Seventy Six Lakh Two Thousand Three Hundred and Twenty Seven only).


