## **Abstract**

Procurement of 11kV Aerial Bunched Cables of sizes 3X150+Insulated Messenger 1X120 sq.mm -352km and 3X120+Insulated Messenger of 1X95 sq.mm-862km-Ratification-Orders Issued.

## ORDER

As per the Purchase Plan 2022-23 and 2023-24, two-part tender was invited for the procurement of 352km of 11kV Aerial Bunched Cables of sizes 3X150+Insulated Messenger 1X120 sq.mm and 862 km of 3X120+Insulated Messenger of 1X95 sq.mm on *variable* price basis on 19/12/2022. Four bidders participated in the tender and three were prequalified.

M/s Tirupati Plastomatics Pvt Ltd has quoted the lowest price for 3X150+1X120 sq.mm (insulated messenger) HT ABC.M/s SBEE Cables(India) Ltd has quoted the lowest price for 3X120 +1X95 sq.mm(insulated messenger) HT ABC . During negotiation by the Director (D,IT and SCM) , the firm reduced Rs1000/km on their quoted basic price.

The total financial commitment as per the quoted rate for procuring 3X150+1X120 sq.mm (insulated messenger) HT ABC and for 3X120 +1X95 sq.mm(insulated messenger) HT ABC is Rs.125.56 Crore.

The Purchase Committee meeting held on 18/05/2023 discussed the matter and approved the proposal for purchase and decided to place purchase orders due to urgency of material reported and thereafter placing before the Board of Directors for ratification since the financial commitment involved in the purchase is above the present delegation of powers of Purchase Committee (Rs 50 Crore).

Based on the Purchase Committee decision the above action has been initiated by Chief Engineer(SCM) and placed Purchase orders with M/s.SBEE Cables(India) Ltd and with M/s.Tirupati Plastomatic Pvt Ltd, incurring a total financial commitment of Rs.125,56,41,077.44 (Rupees One Hundred and Twenty Five Crore Fifty Six Lakh Forty One Thousand and Seventy Seven only).

Complying the direction of Purchase Committee, ratification was sought for the action taken by the Chief Engineer (SCM) in placing Purchase orders and the matter was placed before the Board of Directors' meeting held on 27.07.2023 as per note read 2<sup>nd</sup> above.

Having considered the matter in detail, the Board of Directors in their meeting held on 27.07.23.

Resolved to ratify the action taken by the Chief Engineer (SCM) in placing Purchase orders with M/s.SBEE Cables(India) Ltd, Bangalore for 862 km of3X120+Insulated Messenger of 1X95 sq.mm HT ABC and with M/s.Tirupati Plastomatic Pvt Ltd for 352 km of 3X150+

1X120 sq.mm (Insulated Messenger ) HT ABC in compliance with the Purchase Committee decision dated 18.05.2023.
