ORDER

Total land required for the implementation of Mankulam HEP is 80.013 hectares which include 11.913 hectares of forest land, 15.16 hectares of river bed and 52.94 hectares of land under private possession.

Government as per the G.O read as 1st above had approved a comprehensive Rehabilitation and Resettlement Policy and package for land acquisition in the state and the same was adopted in KSEBL as per B.O read as 2nd above.

As per B.O read as 3rd above sanction was accorded to rehabilitate 77 families whose land and buildings were acquired by KSEB for the implementation of the above project, who became landless and homeless with no salaried income and whose annual income is below Rs. 75,000/-, by providing 3 cents of land each. Accordingly, an extent 1.55 Ha. of KSEB's land in survey No.229 of Block No.10, Kunchithanni Village, Devikulam Taluk adjacent to Sengulam Dam at Anachal in Idukki District was identified for the rehabilitation of the affected persons of the project.

KSEBL had accorded sanction to provide 3 cents of land to 37 beneficiaries till now, as per B.Os read as 4th to 8th above.

The Chief Engineer (Civil - Investigation & Construction Central) as per the note read as 9^{th} above has reported that the following 5 land holders who had already handed over their land and buildings for the implementation of the project are eligible to get 3 cents of land as compensation.

- 1. Sri. Chacko Devassia, Thekkumkattil House, Mankulam.
- 2. Sri. Santhosh M.S, Mukalel House, Mankulam.
- 3. Smt. Aleyamma Sebastian, Anchanickal House, Mankulam.
- 4. Smt. Bindumol Antony, Anchanickal House, Veliyampara, Mankulam.
- 5. Smt. Mary Thomas, Vadakarolickal House, Mankulam.

The Chief Engineer (Civil - Investigation & Construction Central) has requested sanction for the allotment of 3 cents plot each to the above 5 persons from the land in possession of KSEBL in Survey No. 229, Block No. 10, Kunjithanni Village, Devikulam Taluk adjacent to Sengulam Dam at Anachal in Idukki, which is earmarked for the rehabilitation of the persons affected due to implementation of the project.

The matter was placed before the Full Time Directors as per note read as 10th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 11.08.2023 has resolved to accord sanction to allot 3 cents of KSEBL's land in Survey No. 229 of Block No.10, in Kunchithanni Village, Devikulam Taluk of Idukki District to each of the following 5 land holders who had already handed over their land and residential buildings for the implementation of Mankulam HEP and are eligible to get 3 cents of land as compensation with no salaried income and annual income is below Rs 75,000/-.

Further resolved that the above decision shall be as per Government of Kerala R&R package and subject to eligibility.
