ORDER

The Full Time Directors of the KSEBL through circulation has decided to appoint Sri. Basheer. The appointment will be in consonance with the scheme envisaged under the B.O read as 1st above and the KSEBL reserves the right to terminate the appointment at any time without assigning any reason. The Advocate will be paid fee and expenses as per the rules prevalent in the KSEBL from time to time. He will be free to have other engagements, but shall not accept Vakalath and tender advice against the KSEBL in any matter during his tenure as Standing Counsel of the KSEBL. The Advocate appointed as Standing Counsel shall safeguard the best interest of the KSEBL. In case of any default, the counsel shall be liable to pay the KSEBL, even after he ceases to be the Standing Counsel, damages equal to the loss or injury incurred or sustained by the KSEBL as per the Board Order read above.

It is further resolved to disengage Sri. Aravindakshan. K, as Standing Counsel of the KSEBL at Wayanad. The Nodal Officer (Litigation), Electrical Circle, Kalpetta shall ensure proper handing over of the case files with proper acknowledgment of case wise and stage wise remarks from the erstwhile Standing Counsel.


