- 2. To allow the reliefs ordered as per the Government Order dated 29.06.2021 to Industrial/Commercial consumers and Cinema theatres in anticipation of a favourable approval from Hon'ble KSERC.
- 3. To authorize the Chief Engineer (IT&CR) to make necessary modification in the billing software for LT consumers and for HT/EHT consumers to allow prescribed relief on fixed charges/demand charges applicable to Industrial/Commercial consumers and Cinema theaters.

- 6. To entrust the Chief Engineer (commercial & Tariff) to file petition before the Hon'ble KSERC seeking approval for relief packages ordered as per the Government order dated 29.06.2021 to Domestic consumers under NPG/BPL category.
  - 7. To approve the draft petition attached to be filed before the Hon'ble KSERC.
