Annual Performance Appraisal Report (APAR) was introduced to make an objective evaluation on the capability and quality of an officer in the performance of his/her duties and to assess his/her capacity in different assignments / responsibilities. The report evaluates the manner in which the officer has discharged his/her duties during the period of reporting and a bench mark grading has also been introduced for screening the officer's potential for higher position. The Bench Mark Grading System for evaluating the efficiency of officers has come into force in KSEB Ltd vide B.O. read as 2nd above.

The Secretary (Administration) proposed to convene the adhoc meeting of the Departmental Promotion Committee (Higher) with a proposal for inclusion of officers in the Civil Wing belonging to the cadre of Assistant Executive Engineer (Civil) who are to be considered by the committee for being included in the Select List for promotion to the cadre of Executive Engineer (Civil) for vacancies arising till 31.12.2023. Accordingly the adhoc Departmental Promotion Committee meeting (Higher) for considering the promotion of Assistant Executive Engineers in the Civil Wing was convened on 09.05.2023 in the Board Room, 7th Floor, Vydyuthi Bhavanam, Pattom, Thiruvananthapuram, with the Chairman and Managing Director, KSEB Limited in the chair.

Out of the seven members of DPC (Higher), five members were present in the adhoc meeting. The committee after examining all the aspects in detail has approved the following officers for inclusion in the Select List for 2023.

Assistant Executive Engineer (Civil) to Executive Engineer (Civil)

Forty Eight numbers of vacancies are anticipated in the cadre of Executive Engineer (Civil) in the year 2023. An adhoc Departmental Promotion Committee (Higher) meeting was held on 27.04.2023 which considered the first Six nominations of senior most Assistant Executive Engineers. The Select List was published on 28.04.2023 and all of the selected candidates were promoted. Adhoc Departmental Promotion Committee (Higher) meeting considered the balance nomination of 74 senior most Assistant Executive Engineers under Degree Quota (95%) and 2 senior most Assistant Executive Engineers under Diploma Quota (5%) along with their APARs and connected documents.

The Bench Mark Grading fixed for promotion from the cadre of Assistant Executive Engineer (Civil) to Executive Engineer (Civil) is two very good and one Good.

The Assistant Executive Engineers (Civil) who have satisfied all the criteria enumerated in the Board Orders read as 1st and 2nd above and eligible to be included in the Select List for 2023 of Assistant Executive Engineer (Civil) to be promoted to the cadre of Executive Engineer (Civil) are as follows:

There are some litigation, namely WPC No 21167/2018 filed by Sri. E J Joseph and Smt. Sheela Josephine, WPC No. 1499/2019 filed by Sri. Suresh P B and WPC No. 32071/2019 filed by Smt. Mini G R concerning the seniority of Assistant Executive Engineers (Civil) of the graduate quota pending judgment before the Hon'ble High Court of Kerala. In the interim order dated 27.6.2018 in WPC No. 21167/2018 the order reassigning the promotion of Sri. E J Joseph and Smt. Sheela Josephine was stayed by the court and the stay extended till further orders. Though there are no stay orders on the other two WPCs, the court held that operation of the re-assignment order and promotion, if any, in the meanwhile will be subject to the final outcome of the petitions.

The adhoc DPC decided to consider the nominations of the above officers along with the others in the nomination list, subject to the condition that their inclusion in the select list and subsequent promotion, if any, will be subject to the final outcome of the petitions filed by them and the position of the others in the select list and promotion, if any, will also be subject to the final outcome of these petitions.
