### ORDER

The water pumping and storage system has been proposed for the drinking water supply schemes at various locations in Idukki District, under Jaljeevan mission, a joint venture of Central and State Governments. It is envisaged for providing drinking water supply to Rajakkad, Baisan Valley, Rajakumari, Senapathy, Konnathadi, Udumbanchola Panchayath areas in Idukki District. One Cent land near to Ponmudi Dam has been requested for constructing transformer control room and allied equipment along with water lines of the pumping system for taking 22MLD water from Ponmudi Dam using floating pumps.

As per the report from the Civil wing, the land requested for the control room is in the catchment area of the Dam and they have no objection in issuing permissive sanction to KWA for the subject project.

The matter was placed before the Full Time Directors as per the note cited 3<sup>rd</sup> above and the B.O. order read as 4<sup>th</sup> above was issued according permissive sanction to KWA for using one cent of KSEBL land near Ponmudi Dam area for constructing transformer control room and allied equipment along with water lines of the pumping system for taking 22MLD water from Ponmudi Dam using floating pumps. It was issued subject to the following conditions.

- KWA have to obtain NOC from the Forest Department before commencement of the work .
- The lease charges of the said land portion to the Forest has to be paid by KWA.
- The damages, if any, caused to the KSEBL installations, road etc in the locality may be restored to its original condition by KWA, by executing an agreement.

Also authorised the Chief Engineer (Generation) to issue NOC to KWA and Deputy Chief Engineer, Generation Circle, Meencut to sign the agreement on behalf of KSEBL.

Meanwhile, it is reported as per letter read as 5<sup>th</sup> above that the said one cent land is not Forest land and is within catchment area of Ponmudi Dam and is KSEBL land with teak plantations managed by the Forest department. Hence it is recommended to modify the conditions specified for giving permissive sanction as follows:

- KWA have to obtain NOC from the Forest Department before commencement of the work.
- The damages, if any, caused to the KSEBL installations, road etc in the locality may be restored to its original condition by KWA, by executing an agreement.

The above matter has been placed in the FTD as per note read as 6<sup>th</sup> above. Having considered the recommendation, the Full Time Directors through circulation resolved to accord permissive sanction to KWA for using one cent of KSEBL land near Ponmudi Dam area for constructing transformer control room and allied equipment along with water lines of the pumping system for taking 22MLD water from Ponmudi Dam using floating pumps subject to the following conditions:

- KWA have to obtain NOC from the Forest Department before commencement of the work in the said land.
- An agreement shall be executed to the effect that the damages, if any, caused to the KSEBL installations, road etc in the locality may be restored to its original condition by KWA.
- The Chief Engineer (Generation) is authorised to issue NOC to KWA and authorize Deputy Chief Engineer, Generation Circle, Meencut to sign the agreement on behalf of KSEBL.
- While communicating to KWA, the decision taken in the meeting by the Hon'ble Chief Minister regarding Escrow account and dues to KSEBL shall be referred.

Further resolved to cancel the B.O. read as 4<sup>th</sup> above.

Orders are issued accordingly.
